## RELEASE OF LIABILITY

These risks include, but are not limited to, loss of control, collisions, obstacles, variations in terrain, problems with tack, and unexpected actions of the horse.

I represent that I have no health or physical problem(s) that will interfere with horseback riding. I represent that I have no special needs and, therefore, do not require any special care or attention. I also represent that I have no physical and/or mental condition that warrant any special attention, care, or instruction.

I agree to accept and assume all (100%) of the risk involved in this activity and, in doing so, specifically acquit, relieve, exempt and release CIRCLE H STABLES INC., RANCH RUDOLF INC., affiliates, agents, officers, directors, owners, contractors, and employees (collectively, the "Released Parties") from any and all claims of injury, death, accidents or damages sustained or occasioned by this activity. I agree to indemnify and hold harmless the Released Parties for any and all claims brought by any third party.

I accept total responsibility for any and all medical expenses (including transportation to and from any medical facility) that may be incurred while participating in this activity. I also authorize Circle H Stables Inc. and/or Ranch Rudolf Inc. to seek immediate medical attention if it deems appropriate, at its sole discretion.

I grant Circle H Stables Inc. and/or Ranch Rudolf Inc. permission to use any photograph, videotape, or any other likeness which may be taken while participating in this activity.
